WORLD WILDLIFE DAY 2025




On 20 December 2013, at its 68th session, the United Nations General Assembly proclaimed 3 March (day of signing the <u>Convention on International Trade in Endangered Species of Wild Fauna and Flora</u>), World Wildlife Day 2025 to celebrate and make aware public opinion on animals and wild plants of the world.

The international day 2025 "Wildlife Conservation Finance: Investing in People and Planet", explores how we can work together to make our current insufficient financial flows more effective and sustainable to build a resilient future for both people and the planet.

With over 1 million species estimated to be threatened with extinction, and facing the intensifying triple planetary crisis, innovative finance for wildlife conservation is more urgent than ever. More than half of the world's GDP is dependent on nature, making biodiversity loss a significant threat to financial stability.

For World Wildlife Day 2025, join us in exploring how we can work together to finance wildlife conservation more effectively and sustainably and build a resilient future for both people and the planet.

Wild animals and plants, from the highland steppes to the coral reefs, are intrinsic to the intricate web of life on Earth. They sustain ecosystems, regulate natural processes, and support biodiversity, providing essential services that underpin human livelihoods and contribute to the achievement of our <u>Sustainable Development Goals (SDGs)</u>.

THE FIVE ESG TRENDS THAT WILL SET THE SUSTAINABILITY AGENDA IN 2025



Forética presents the report 'ESG Trends 2025. Keys to the corporate sustainability agenda'. The document includes the key aspects that will focus the action of organizations in 2025 in environmental, social and transparency and good governance (ESG), and also highlights the focus of attention to prioritize a practical business action towards sustainable development, impact and linked to competitiveness.





In its now traditional trends report, Forética identifies five key trends in sustainability in 2025: regulatory disinflation at the European level to reduce regulatory pressure without forgetting the main objectives in terms of sustainability; complexity in reporting systems following the CSRD directive and the impact of the Omnibus package; greater involvement of the conscious consumer and the fight against greenwashing; acceleration in the climate adaptation plans of companies and governments; and the transition to zero net emissions in a complex geopolitical environment.

The study analyzes the milestones that will guide corporate agendas at a time when sustainability is becoming increasingly important. The events of 2024 in the political, environmental and social spheres have highlighted the need to evolve towards responsible economic models that are capable of anticipating future challenges and in which companies take a leading role in contributing to achieving a sustainable transformation.
